YOU MUST COMPLETE THIS SEPARATE FORM PRIOR TO CHECKING IN FOR A TRIP PARTICIPANT AGREEMENT, RELEASE, AND ASSUMPTION OF RISK

In consideration of the services of Great Northern River Guides LLC and Great Northern Resort and Lodging LLC, GN Management Co., Inc, their agents, owners, officers, volunteers, participants, employees and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "GNWRR"), I hereby acknowledge the following risks that exist in the sport of river rafting, and agree to release and discharge GNWRR, on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows:

- 1. I acknowledge that rafting on rivers entails both known and unanticipated risks, which could result in physical or emotional injury, paralysis, death or damage to myself, to property or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity.
a. The risks include, among other things: whitewater rapids will be encountered, I can be jolted, jarred, bounced, thrown to and fro and shaken about during rides through some of these rapids. It is possible that I could be injured if I come in contact with food boxes, other storage containers or other fixed equipment necessary to the operation of the expedition and the outfitting of the raft. Rafts could turn over or I could be "washed" overboard. I can slip or fall during a hike, resulting in damage to equipment or personal injury. Accidents can occur getting on and off the raft. Rafts are slippery when wet. Exposure to the natural elements can be uncomfortable and/or harmful. I am aware that this exposure could cause sunburn, dehydration, heat exhaustion, heat stroke and heat cramps. Also, prolonged exposure to cold water can result in hypothermia. Death and accidental drowning is also a possibility.
b. Furthermore, GNWRR guides have difficult jobs to perform. They seek safety, but they are not infallible. They might not be fully informed by a participant of their fitness or abilities. The weather, the elements of the terrain, and the river are unpredictable and uncontrollable. They may give warnings or instructions that are not fully understood by the participants, and the equipment being used might malfunction. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.
2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.
3. I hereby voluntarily release, forever discharge and agree to defend, indemnify and hold harmless GNWRR from any and all claims, demands or causes of action, which are in any way connected with my participation in the activity or my use of GNWRR's equipment or facilities, including any such Claims which allege negligent acts or omissions of GNWRR.
4. Should GNWRR or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
5. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage to myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.
6. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portion shall remain in full force and effect.

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against GNWRR on the basis of any claim from which I released them herein. I have had sufficient opportunity to read this entire document. I have read and understood it, and I agree to be bound by its terms.
